Professor **James Allan**, a Canadian by birth, was educated at W.A. Porter Collegiate, Scarborough, Ontario, and at the Queen's University, Kingston, Ontario, the London School of Economics and Political Science, and the University of Hong Kong. After working at the Bar in Toronto and in London, he has since taught in New Zealand, Hong Kong, Canada and the United States before appointment as Garrick Professor of Law at the University of Queensland in 2004.

The Honourable Dr **John Bannon**, AO, was a member of the House of Assembly in South Australia from 1977 to 1993. During this period he was Leader of the Labor Party from 1979 until 1992 (Leader of the Opposition, 1979-1982; Premier and Treasurer, 1982-1992). Master of St Mark's College, University of Adelaide, 2000-07, he wrote a biography of Sir John Downer, *Supreme Federalist* (2009). He died late in 2016.

Nicholas Cowdery, AM, QC, BA LLB (Sydney), Hon D Laws (Wollongong), FAAL, was the Director of Public Prosecutions for New South Wales from 1994 to 2011. Prior to that he had been a public defender in Papua New Guinea (1971-1975) and a Barrister in private practice in Sydney (1975-1994), taking silk in 1987. He served as an Associate (Acting) Judge of the District Court of NSW for periods in 1988, 1989 and 1990. He was appointed AM in 2003. He was inaugural Co-Chair of the Human Rights Institute of the International Bar Association (1995-2000) and President of the International Association of Prosecutors (1999-2005). He is the author of *Getting Justice Wrong: Myths, Media and Crime* (Allen & Unwin, 2001). Since 2011 he has been an Adjunct Professor of Law and a Visiting Professorial Fellow, teaching at the Universities of Sydney, of New South Wales and of Wollongong and publishing in the area of criminal justice. He is a consultant to international prosecuting agencies for various projects. For 2015 he has been Chairman of the Magna Carta Committee of the Rule of Law Institute of Australia.

Professor **James Dalziel** is Dean of Education at Morling College where he is also Professor of Divinity. Previously at the University of Sydney in the Institute for Teaching and Learning, he recently edited *Learning Design: Conceptualizing a Framework for Teaching and Learning online* (Routledge, 2016).

Neil Foster, an Associate Professor of Law in Newcastle Law School at the University of Newcastle, NSW, Australia holds degrees from the University of New South Wales, the Australian College of Theology, Moore College and the University of Newcastle. He teaches and researches in the areas of *Torts*, *Workplace Health and Safety Law*. Since 2013 he has been teaching a new elective course in *Law and Religion*. A member of the editorial board of the *Torts Law Journal*, he was a co-author of the 6th and 7th editions of the Luntz & Hambly *Torts* text, sole author of a 2014 Supplement to that book on *Defamation and Wrongful Interference with Goods*, and responsible for a new chapter in the 10th edition of *Fleming's Law of Torts*. He is the author of *Workplace Health and Safety Law in Australia* (LexisNexis Butterworths, 2012), and an e-book published by Matthias Media, *Pressure Points* (2014) dealing with potential clashes between the Christian faith and recent

Mark Fowler is chair of *CLEAR International Australia Ltd*. He is a Director at Neumann & Turnour Lawyers, Brisbane, a member of the Queensland Law Society Human Rights Working Group and is currently undertaking doctoral research on religious freedom and tax frameworks.

Julian Leeser was elected to the House of Representatives as member for Berowra at the elections of July 2016. He was, for several years, Conference Convenor for The Samuel Griffith Society. Educated at Cranbrook, he took degrees in Arts and Law at the University of New South Wales. He was an elected Australian for a Constitutional Monarchy delegate to the 1998 Constitutional Convention and, subsequently, a member of the No Case Committee for the Republic referendum. In addition to a year as Associate to Justice Callinan of the High Court of Australia, he has been an adviser to the federal Minister for Employment and Workplace Relations (the Honourable Tony Abbott, MP) and the federal Attorney-General (the Honourable Phillip Ruddock, MP). He was subsequently Executive Director of the Menzies Research Centre; he was on the staff of the Australian Catholic University immediately prior to entering the House of Representatives.

The Honourable **Michael Mischin**, MLC, was Attorney-General of Western Australia from 2012 until 2017. He was educated at Scarborough Senior High School and the University of Western Australia. A Senior State Prosecutor prior to election to the Legislative Council in 2008, he was very active in parliamentary committees before appointment to the ministry.

John O'Sullivan, CBE, editor of *Quadrant*, 2015-17, and now international editor, was born in Liverpool in 1942 and educated at St Mary's College, Crosby, and the University of London. He has had a range of editorial posts on both sides of the Atlantic. During the late 1980s he was a special adviser to the UK Prime Minister, Margaret Thatcher. He presently lives in Budapest where he established the Danube Institute. His book, *The President, the Pope, and the Prime Minister*, was published in 2006.

Senator **Scott Ryan**, elected to the Senate in 2007, was appointed Special Minister of State in 2016 and Minister Assisting the Prime Minister for Cabinet in January 2017.
